## **VP Administration:** LTC Jim Webb (absent)

Jim Cunningham reported that LTC Webb has fully immersed himself in the ROTC program for 2011 and making contact with approx 65 schools and 3-4 colleges. Currently working on revising the scholarship applications to make them more user friendly.

#### VP Programs: (Open)

Jim Cunningham gave an overview of the upcoming social program in February and the golf tournament. Has just received an email from MOAA national re the extent of our involvement in their Annual meeting in October and will distribute to the staff..

## VP Membership: LTC Randy Hoff

Advised the national dues had increased from \$28 to \$30, and a new class of membership was being developed for the junior and senior ROTC members. Provided annual report and MOAA's top ten goals for 2011 and reasons to join, plus copies of the new enrollment forms. Ed Stone noted MOAA national was looking at ways for national members to be assigned to local chapters and that chapters should give their input to the TCC for its position on how this can be done. Ed Marvin may have more on this as a current member of the Chapter Affairs Committee. Provided the latest numbers from the membership chart: 1152 members comprising of 236 Active Duty, 248 Auxiliary and 668 Retired.

**President:** Maj Jim Cunningham – Gearing up for the State's legislative activities – the main focus being on retaining what the military already has. ### **Discussions & Review:**

a) 2011 Budget: Presented by David Patrick. Projected deficit in Operation account of \$4075 but hope to make this up with non dues revenue. Scholarships have increased to \$10,400 in 2011, and golf tournament proceeds budget is based on last year's actual receipts. Motion to accept the budget as presented was made by Frank Rohrbough and seconded by Lisa Skopal. Motion carried. Mac McDonald pointed out the negative projection in the social programs and it was explained that higher food costs combined with the free lunches that are given out to scholarship winners, coverwrap members etc produced a deficit which was not budgeted for in prior years.

- d) **Golf Tournament:** Director of Golf, Frank Rohrbough advised the 2011 Golf Tournament is set for 15 April. Motion was made for the Board to approve the \$1,000 expenditure of chapter funds initiate the Golf Tournament. Seconded by Mac McDonald. Motion carried. Frank encouraged all Board members to participate in the tournament and assist in gathering door prizes.
- e) **TCC Advocating in Austin:** Jim Cunningham advised the Board of the planned Advocating in Austin on Feb 2-3 involving all Texas chapters. Interested participants should contact David Patrick. Talking points will be provided. Frank Rohrbough advised he was recently in Washington DC and met with Steve Strobridge of MOAA's legislative staff. Tricare may well be cost shared between members and fee increases likely to be released on Feb 14<sup>th</sup>, and will likely be adjusted with future COLA increases.
- f) Other: Mac McDonald inquired as to the planning of the Board meeting dates. Being on the same day as a luncheon means he is unable to bring guests. Matter was tabled until the next Board meeting for additional input.
