Regulation that occurred in the regular session of the Texas legislature was very productive for veterans. The largest impact was 1) the Veteran owned businesses being recognized by the state at HUBs (historically underutilized businesses). 2) The surviving spouses of military members who were killed in action or died whilst in service now receive 100% property tax exemption. This affected 550 widows in Texas. Changes to the Hazelwood act were not passed and the administration of it was changed to the Texas Veterans Commission. The disappointments included not getting the start date erased for the property tax waiver for surviving spouses.

MOAA-AC is an integral part of the Texas Coalition of Veterans Organizations and this entity is becoming well known at the state level. There is a new slate of officers for TCC and a quarterly in person meeting in Tyler in October.

Both Jim and David Patrick are heavily involved with the San Antonio Area Foundation and the Alliance for Veterans & Families (AVF), and the San Antonio Coalition for Veterans SACV). AVF and SACV will merge into one and be called the San Antonio Coalition for Veterans and Families. It aims to work the 12 county area helping the military.

The chapter was again awarded the Five Star Level of Excellence and will be presented with the streamer at the MOAA Annual meeting in Colorado Springs in November.

National MOAA Updates

MOAA Board Member: Barbara Ramsey

National MOAA has been busy with Storming The Hill campaign. Together with Ed Marvin 28 key legislative offices in 3 buildings were visited. Age and lack of experience with the military was surprising. Discussed bills dividing the house and senate that greatly affect the lower ranking military personnel. Discussed healthcare, sexual harrassment, tricare premium and mail order drugs (many of which are made overseas, the chemical make up of which may affect patients differently than "brand names").

The Storming the Hill regarding the SBP/DIC was a successful event. MOAA also working with Secretary Hagle with the sequestration issues.

 - David Patrick briefly reviewed the latest updates to the Plan's action items.
- b) **Golf Tournament:** Tournament co-chaired by Frank & Stephen Rohrbough is meeting bi weekly. Still looking for a title sponsor but revenue will be increased by using the new venue at River Crossing. Warrior players are being invited from Operation Homefront and Warrior and Family Support Center. Their families can partake of the River Crossing's pool and facilities.
- c) **Other:** Susie Tolman was awarded a certificate of thanks from the Warrior and Support Center for her coordination of the Cookie Angels.
