## b) Scorecard Update

**Priority 1 – Membership & Retention** - Felix Santiago advised membership retention is being fought aggressively by Trish sending out renewal letters and emails and by Felix sending personal emails. The priority is a balancing act between achieving small gains and the unavoidable losses due to death and PCS of the active duty. The membership chart shows a net gain of 6 for a total of 1306 members. The goal is to emphasize paid memberships, the biggest block being from the retired folks, and in January we had 696 retired and in August we have 885. The % of paying members aligns with MOAA national at 65.5%.

- 1.1 Challenges continue as the opportunities are limited due to COVID.
- 1.2 Facing similar limitations. A slide about us is included in their orientation presentation and over 2,000 service members have been exposed to this media. If a member of MOAA national, they will also be reached via the NRT reports produced by MOAA as they move into our area and submit a change of address.
- 1.3 Younger members are participating in the ad hoc committees and chapter activities.
- 1.4 The recent luncheon at the Petroleum Club was a welcome get together.

- 1.5 Soldier's Angels is now a standard inclusion in The Lariat.
- 1.6 The NRT reports provide by MOAA national has increased membership by 552 (42%). Hopefully we will retain them after their free 3-month trial period despite little in person action.
- 1.7 Awaiting Board decision.

Barbara asked if the satellite chapters were bringing in new members and Felix advised that Jim & Dottie Connor at Blue Skies and Joe & Janet Morgan at the ARC were integral in membership retention.

**Priority 2 – Positive Financial Position** – Kitty Meyers pointed out the budget has been exceeded on Non-Dues Revenue for Corporate Partnerships and Lariat Advertising. Hopefully all will contribute to the upcoming Big Give on Sept 23.

**Priority 3 – Legislative Efforts** – Jim Cunningham advised the recent legislative session contained very little that affected the military. A couple if items include one that will be put to a vote in November, namely the Ad Valorem benefit should be passed to the spouses of those killed in action, and another easing the restrictions on state medical licenses and certifications for pcs-ing military and their spouses. A full list can be found on the chapter website.

Will be attending the MOAA annual meeting with Kitty in October to receive the Level of Excellence Awards.

## c) By Law Revisions

Lengthy discussions on various points concluded deleting the last sentence in Article II Section H and to have an option for a Corporate Friend of the Chapter and an Individual Friend of the chapter priced accordingly (CP at \$100 and Individual at \$25). Additionally, Article VII Section D the last sentence should replace the first "President" with "Chairman of the Board". The rest of the proposed highlighted amendments were acceptable.

Ed Marvin made a motion to accept all the changes highlighted in addition to the recent amendment. Bob Blake seconded. All were in favor. David to put together a recap for The Lariat that will be voted upon at the November Annual meeting.

# d) Golf Tournament

Frank Rohrbough advised the player capacity had been reached, indicating a move to the Quarry will be a successful one. Meetings will be held bi-weekly through the end of September and then weekly thereafter.

There is no title sponsor this year, but Lisa and her team are still working hard to bring in more sponsors.
