VP Administration: LTC Jim Webb

Absent. Now servicing 120 JROTC units. The majority are Army after having forged a relationship with the 5th Army ROTC Brigade. Working on similar principle with the Air Force and Navy/Marine ROTC. Such an impressive number of schools services should warrant recognition by MOAA national in the Affiliate.

VP Programs: (Open)

President: Jim Cunningham

The chapter was designated a Five Star Chapter of Excellence again in 2014. Will be presented with the streamer at the upcoming annual meeting in October in Arlington, VA. All scholarships have been distributed except for one – the Torrey Scholarship.

Continuing to represent the chapter with Military Veterans Community Council (MVCC) as he and David Patrick are involved in both the employment and economic development teams. Working with Army North on the retiree Committee and The Soldier For Life program.

General Halborsen's reception he mentioned a new initiative to help find widows to assist them in getting the benefits they were entitled to.

Both MOAA/TCC and the Texas Veterans Commission are gearing up for the 84th Legislative session. Concern is centered on who will replace Senator Van de Putte as Chair of the Veterans Affairs and Military Installations Committee if she wins as Lt Governor, and also if she loses as Dan Patrick, her opponent vows to oust every democrat committee member. Issues at stake in the 84th Legislature will be

- 1) Updating the tax exemption from a dollar amount to a % for partially disabled veterans (cost will be about \$25 million)
- 2) Making the process of Certifications easier for transitioning veterans
- 3) Getting out the vote to deployed military members, or those who live in remote areas
- 4) Removing the cap of 26 years of age for the Hazelwood Act

National MOAA Updates:

MOAA Board Member: Ed Marvin

The Strategic Planning program at the MOAA national levels hopes to emphasize the importance of Chapter & Council Affairs. They will continue highlighting the importance of recruitment and of legislative affairs and advocacy.

Frank Rohrbough advised of a new 50th Anniversary of Vietnam War Commemoration project that gives recognition to those who served in the Vietnam era. It is a 13 year event cumulating on Nov 11 2025. Their website asks for civilian organizations such as MOAA and its local chapters to sign up to participate and become an advocate by holding 2 events per year directed towards Vietnam Veterans. He will distribute more information through email.

Discussions & Review:

a) Strategic Plan Update:

Jim Cunningham reviewed the current status on the Plan's action items.

b) Legislative Update:

Working with TVCO and TCC to identify items to present to the 84th legislature.

c) Golf Tournament:

Frank Rohrbough advised Golf Tournament had 106 players – attributed some of the non participation (down from 49 to 20) from the River Crossing Members to the fact that golf carts were restricted to the paths only because of the drought. Somewhat disappointed in the number of warriors - 7 were registered and only 2 showed up. Will be following up with delivering the plaques, thank you letters to the sponsors, visiting the primary sponsors to encourage greater involvement next year.

d) Successor Planning:

Ed Marvin reiterated the importance of succession planning. Should formulate a committee to search for candidates. Will approach chapter membership and then come to Board with recommendations.
