#### When A Stroke Strikes

About every 40 seconds someone in the United States has a stroke. These potentially devastating events are nearly always caused by a blood clot clogging an artery supplying the brain (ischemic stroke).

How to spot a stroke - use the acronym BEFAST:

- B Balance
- E Eyes blurred vision
- F One side of the Face is drooping. There is a weakness especially on one side. Difficulty in speaking or understanding speech. A feelling of prickly heat or cold may occur.
- A Arm and or leg weakness may occur.
- S Speech is difficult. One side of the mouth seems paralyzed.
- T Time to call for an ambulance immediately.

It is best to call 911 and get the person to a hospital as soon as possible. New guidelines have increased the time for action to between 16 to 24 hours. Do not use your own car to drive to the Emergency Room as ERs take ambulance patients first.

They are prepared to give an IV medication immediately if indicated. Anyone with a suspected transient ischemic attack (TIA) will receive a brain imaging test immediately followed by additional tests to help the doctors pinpoint the possible cause of the TIA. They want to prevent a future TIA or a more serious stroke. As many as 40% of people who have a TIA and don't get treatment have a permanent stroke within a year.

Alteplace is the drug usually used to bust the clot. But when it is not effective for larger clots a device or stent riser is used to reach into the blood vessel and grab the clot. This is known as a thrombectomy.

## Judge Roy Bean

Within the legends of the Wild West, the name of Judge Roy Bean stands out. He is immortalized in poetry, song, music and legend. Like most legends, his story is based upon partial truths. He was a drunkard, quarrelsome, a liar, a poultry thief and a spouse abuser. But – he did have a gentle good streak. He was kind to children, widows and the needy.

Records indicate that he was born in Shelby County Kentucky circa 1825. His birth certificate reads Phantly Roy Bean. He hated the feminized first name and did all he could to eliminate it. He also changed his birth certificate to read 10 years younger.

His colorful background varied. He claimed Canadian citizenship which he later rescinded. His said to have lived in California, but there is no such record. We do know that he spent 17 years in San Antonio, living near Mission Concepcion in an area known as Beanville. He arrived in San Antonio toward the end of the Civil War and lived here for the next 20 years. He went into business with his brother. He married Virginia Chaves, the teenage daughter of a land-holding Mexican with a large family. Bean and his wife had four or five children. He eventually divorced her and moved further west.

His divorce suit was as controversial as his life. The court proceedings were move to Boerne after he claimed that he couldn't receive a fair trial in San Antonio. It seems that he came home one night very drunk and quarrelsome. He battered his wife while she was sleeping. She didn't respond and turned her back on him. Infuriated, he took a hot burning stick from the fireplace and burned her whole backside. In the trial, the judge asked to see the evidence of the violence. This was not a reasonable request to a "proper" lady – to drop her draws to a room of men. The charges were dropped. Bean later replied that he would have been sent to jail for life if

she had shown the extent of the scars.

He settled in Langtry, Texas, a stop on the transcontinental railroad. Now in Langtry, his saloon was in a tent for the thirsty railroaders. The railroad was trying to find workers to complete the line. All they could find were drunks, gamblers, roughs, robbers and pickpockets. Without some semblance of law and order, they could not complete the railroad. Bean was the best they could find so he was appointed judge. He called himself the "Law West of the Pecos."

This drunkard's colorful life continued. He actually became a fairly good jurist. He fined a deceased man in a coffin \$40 for having a loaded pistol in the casket. The fine was given to Bean's court. He killed a Mexican in a duel. He escaped hanging. He carried a packet of unsigned warrants in his bag so that he could immediately sign a warrant and arrest the man. He cheated a farmer out of a considerable amount of money in a cattle sale because his cattle were not branded. The farmer couldn't prove they were freerange cattle. He also exonerated an Irishman for killing a black man because there was nothing in the Texas law book regarding killing blacks by the Irish.

Ever the braggard, he called himself a Civil War hero and a veteran of the French and Indian War. He stole charcoal from a Mexican charcoal dealer. Once he was so drunk in court that he couldn't stand up. Someone challenged his ability to judge and he pulled out his pistol to shoot. A Texas Ranger restrained him by putting him in chains until he sobered up.

Judge Roy Bean died in 1903. You will find a memorial to the Judge in the Langtry Texas Visitors Center. His life and good deeds are lauded.

## **Summary of Proposed By Law Amendments**

#### ARTICLE VII - ELECTED OFFICERS & APPOINTED STAFF

A.The elected officers of the Chapter shall be:

- 1. President
- 2. President-Elect
- 3. Vice President Membership Recruitment and Retention
- 4. Vice President Programs
- 5. Vice President Legislative Affairs
- 6. Secretary
- 7. Treasurer

D. In the temporary absence of the President, his/her duties shall be performed by the President-Elect or the Vice President Membership Recruitment and Retention.

\*\*\*\*\*\*

- E. In general, the duties and responsibilities of the Chapter elected officers shall include, but are not limited, to the following:
- 1. President: To direct the affairs of the Chapter and to preside at meetings.
- 2. President Elect: Second in line to the President and performs the duties of the President if the President is not available. Expected to assume Presidency upon term completion of the incumbent President.
- 3. Vice President Membership Recruitment and Retention: Third in line to the President and performs the duties of the President if the President and the President-Elect are not available. To maintain and protect membership files and to promote the procurement of new members.

\*\*\*\*\*\*

- G. In general, the duties and responsibilities of the Chapter appointed staff shall include, but are not limited, to the following:
- 1. Public Relations/Social Media Officer: To be in charge of publicity, public relations and all aspects of social media.
- 2. Personal Affairs Officer: To provide counseling services for the Chapter.
- 3. Chaplain: To provide an invocation and a benediction at all meetings and to advise in cooperation with the Personal Affairs Officer on survivor's assistance matters.
- 4. Legal Counsel: To provide legal advice to the Executive Staff and Board of Directors on Chapter matters.
- 5. Webmaster: To maintain the website for the Chapter.
- 9. Transition Liaison Officer To provide professional guidance and support for MOAA members/spouses in job transition from the military to the civilian sector.
- 12. Advertising Coordinator: To assist in the financial stability of the Chapter, i.e. to generate and sustain stable, consistent and diverse revenue sources for long-term growth and expansion of the Chapter.
- 13. Awards and Scholarships Committee Chair: Grooms future MOAA members by implementing policies and procedures to allocate resources for the chapter's awards and scholarship programs for high school and college students who have a current or future affiliation with MOAA.
- 14. Satellite Liaisons: Acts as the focal point and liaison between the Alamo Chapter leadership/staff and the Satellite.
- 15. Active Duty Military Liaison: Ensures the Chapter maintains a strong tie to officers who are actively serving, to include those in the Reserves and National Guard.

#### **ARTICLE X - DUES**

- A. The annual membership dues for the Chapter shall be established by the Board of Directors and will be due on the anniversary of the member's join date. A member whose dues have not been paid by 1<sup>st</sup> of the month following two email and three US Postal Service mail reminders will be considered delinquent and will be dropped from the membership rolls. A delinquent member may be reinstated at any time upon payment of dues for the current year.
- B. Other variations of the dues structure to better support recruitment and retention efforts particularly those involving active duty -- and the fiscal solvency of the Chapter will be at the discretion of the executive staff with approval by the Board.

# **Transitioning Tips**

#### Did You Know That Spouses Transition With Every Move?

I spent yesterday eve at a Military Spouse Professional Network assisting with resume counseling. One gal had a good idea of where she wanted to go and how to get there. She had some employment experience in the desired career field. Her focus was on building her network in San Antonio. The second gal was not only new to San Antonio, but had recently relocated from Germany. She had the education with limited work experience. The challenge was helping her focus on accomplishments in her related field that could explain her story to prospective employers.

This highlights the challenges and the needs of the military spouse. First to dispel a misconception – all spouses are not female. The number of men opting to support the female military member is increasing daily. They are finding the same challenges that the women face.

Those challenges include juggling child care, frequent relocations, performing the role of single parent when the military member is deployed, etc., etc. If they find employment, will the job be one that fully utilizes their skills or will they be under-employed. They then must explain these moves and the under-utilized skills when interviewing for the next position.

The first thing that I stress to spouses is not to start the conversation that they are a spouse. Sell the skills and accomplishments that are of interest to the employer. That's what they want to hear. You are marketing and branding yourself to these skills and accomplishments. Don't sell yourself short.

The second thing I stress is networking. Find the groups and organizations that are relevant to the desired career.

Folks who are hiring or know of someone who is hiring may be the next person that you meet at a networking event.

The third thing that I stress is networking with LinkedIn. This digital tool is marvelous for connecting folks with people in their desired career field and/or folks employed by a desired company. A digital connection can lead to a meeting which can lead to a iob.

#### Major General John DeGoes

Maj. Gen. John J. DeGoes is the Commander of the 59th Medical Wing, Joint Base San Antonio- Lackland, Texas, whose mission is to provide deployed and home station health care, graduate medical education and clinical research to enhance Air Force mission readiness. This is the Air Force's largest medical wing composed of seven groups across the \$1.2 billion San Antonio Military Health System, Joint Base San Antonio, supporting more than 240,000 beneficiaries with more than 6,000 military and civilian personnel, residents and students.

General DeGoes graduated magna cum laude, Phi Beta Kappa, from Boston College in 1985. He received a direct commission in 1985 to attend medical school at the Uniformed Services University of the Health Sciences in Bethesda, Maryland, where he graduated Alpha Omega Alpha in 1989. He is a chief physician and flight surgeon. He is board certified in internal medicine, a fellow of the American College of Physicians and a Certified Physician Executive.

Prior to assuming his current position, General DeGoes was the Vice Commander of the 59th Medical Wing. He has commanded the 99th Medical Group at Nellis Air Force Base, Nevada, 1st Medical Group at Langley AFB, Virginia, and the 31st Medical Operations Squadron at Aviano Air Base, Italy. He has also served as Chief Executive Officer of the Mike O'Callaghan Federal Medical Center, a joint venture between the Air Force and Department of Veterans Affairs Southern Nevada Healthcare System,

where he was responsible for the operation of a 104-bed hospital with of a combined eligible user population of over 320,000. General DeGoes has also served as the Command Surgeon for both USAF Central Command and NORAD-USNORTHCOM.


