Have just received a grant from the United Way, with a matching grant from the San Antonio Foundation for a program dealing with child abuse within the military. Searching for an Executive Director who will be heavily involved in its fundraising efforts.

Also involved with the San Antonio planning initiative SA2040 by representing the military community, and reviewing issues such as annexation of land surrounding the military bases. Currently land is both in the city and the county but county land has no zoning authority to prevent encroachment upon the land and it would be beneficial to have the city annex those areas to keep them free from future development.

The TVCO is holding its annual membership meeting in conjunction with the American Legion in Austin on Jan 17. Its Board meeting will be held at the Veterans Summit on Feb 9 in College Station.

Alamo Chapter is hosting the Q1 TCC meeting at the Kendrick Club on Feb 22-23. At least 13 chapters will be represented from the state. Dinner speaker on Friday will be Senator Campbell and as we are hosting all members are highly encouraged to attend, particularly the leadership team and the Board. General Roberson is attending and possible Generals Wiggins and LaBrutta as well.

#### **MOAA National Update:**

**Ed Marvin:** MOAA national is looking for applicants for the next influx of Board members. The bottom up review continues. #### Committee reports-
