In the 2015 Budget notable changes were the addition of 3 College level ROTC scholarships at \$1,000 each. Also added was an inflow category for the Combined Federal Campaign that we hope to be involved in this year. In 2014 accounting inflow was \$10k to the good because of monies from MOAA national and the generosity of our members.

Executive VP Operations: LTC Bill Goforth - Absent. No report.

Vice President Administration: Jim Webb – Absent. Col Peter Hunt advised he and Jim Webb will be emailing all 120+ high school JROTC units plus the local ROTC colleges units to advise them of the scholarships and request information on their award presentations. May take the most recent MOAA national Prospect list and recruit presenters from there.

VP Membership: LTC Randy Hoff – Provided the Top Ten MOAA Goals. Reviewed the Membership chart: Active Duty 367, Auxiliary 203, Former 25, Retired 843 for a total of 1438 members. May not make the 1700 goal this year due to retention issues. No solution currently in play. Ed Marvin suggested the Active Duty are more interested in the bottom line e.g. Tricare. Bill Knehans remembered a tri-fold advising what should be considered at each stage of the military career and suggested a similar approach with renewal notices. Fred Koechley was tasked with finding a replacement display board. Thanked Mac McDonald, Jim Cunningham, Frank Rohrbough, Barbara Ramsey, David Patrick and Dave Padden for their help with recruiting this past year. Nationally the Alamo chapter was the number 1 recruiter. The next Extravaganza will be on Jan 27th.

VP Programs: (Open) – Still need speaker for February – perhaps Kevin Wolfe? Jim to contact Sig Christenson to see if he would moderate a panel of the mayoral candidates for the March meeting, and perhaps have the luncheon in conjunction with AUSA. MOAA Board Chair Tony Robertson would be a good speaker for Scholarship or Blue Skies luncheon.

Buddy Program Status - No updates.

<u>Task Review</u> – Reviewed items remaining on task list. Removed Virtual job fair. Kerry Reyna to contact Janice regarding Historian annual summary. Peter to provide Jim with his and Jim Webb's availability to enable a meeting with them and the new ROTC Commander.

<u>Scorecard Review</u> – reviewed revised 2015 priorities. Priority #1: included retention of key volunteers, increase advertising & marketing of the chapter. Build a speaker's bureau. Recruit spouses for key staff positions. Priority #2: New. Leadership succession planning.

Priority #3: Continuing building & sustaining Community Partnerships.

Priority #4: Increase revenue through advertising from small businesses – focusing on business card size ads, and joint mail outs with corporate partners.

Priority #5: Improve legislative program spearheaded by Robert Blake.
