MOAA-AC CY 2010 Recruiting and Retention Report

1. Membership

The total membership on 31 Dec '09 was 1131, (283 active duty, 590 retired, and 258 auxiliary).

On 31 Dec '10 the total membership was 1152 which shows an increase of 21 members or 2%.

Membership breakdown:

Active members: 236 (47 decrease or -20%) Retired members: 668 (78 increase or 12%) Auxiliary members: 248 (4 decrease or -4%)

2. Give Me 10 (GMT) Membership Retention - CY 2010

During CY '10 130 new GMT members were signed up. Most were active duty. We show that 23% renewed from CY '09.

3. MOAA GMT National statistics - CY 2010

a. MOAA-AC GMT recruiting is #1 in Texas. 63% of the total recruited members in Texas came from MOAA-AC.

b. MOAA-AC GMT recruiting is #5 out of 137 reporting chapters in the country.

4. The Way We Got There

Membership was generated primarily from newcomers gatherings at Ft Sam Houston, local TOPS briefings, Retiree Appreciation Days and the "Gold Bars" program. All were augmented by the constant updating and use of our Recruiting Board for events and aggressive recruiting by key members of the staff/member volunteers.

5. Moving to CY 2011

We will continue utilizing the successful programs mentioned above and expand our efforts as follows:

- A. Initiate an aggressive recruiting effort at the Health Service Command at Ft Sam Houston.
- B. Recruit at local PX's, hospital facilities and newcomers orientations.
- C. Increase MOAA Life Memberships and Lost Patrol members.
- D. Increase the number of active duty members who renew local memberships.
- E. Recruit college ROTC juniors and seniors in the MOAA-AC area of responsibility.
- F. The MOAA-AC Recruiting Goal for 2011 is to end the year with at least 1500 members and is obtainable with the support of the membership.
