Half of the current balance will be spent on 2025 Scholarship awards in March and recommend opening a 9- or 12-month CD for \$35,000 to make better use of the funds in the money market. The current CD valued at \$11,363 matures on March 7 and should be rolled over to a new 6-11 CD at 4%. The 20241099-EZs were filed and accepted by the IRS for both MACEF and Chapter Ops.

New Business:


- a) Due to conflict March meeting will be moved to Wednesday March 5
