MINUTES OF STAFF MEETING Thursday, March 7, 2013

Invocation given and pledge led by Jim Cunningham.

Secretary: Col David Patrick (Absent) - Minutes from February were reviewed and approved for filing.

President: Maj Jim Cunningham – Has initiated meetings with AUSA, AFA and the Navy League. Spoke with 5th Army ROTC Brigade Commander and will pitch MOAA-AC's willingness to help ROTC to their instructors. Also gathering names of Vietnam Vets for Texas A&M for them as a panel to answer questions from ROTC cadets as part of the celebrate Vietnam veterans. Represented the chapter at San Antonio Community Salutes, an organization of community leaders assisting the army by sponsoring the Army Bowl. Legislative committees, ROTC committees and an annual banquet for students and families of those signing for military duty. Meeting with Col Lamoureux after Spring Break. Assisting with a South Texas Employment project for veterans and spouses in helping Joint Base San Antonio becoming involved with transitioning retirees. Ramon Pena of TVC is contact person for this. Also, staff member Al Cote has a new venture and is looking to hire veterans.

Legislatively: 1) Testified before the Military Affairs committee in Austin to assist in easier certification in Texas for transferring professionals (firefighters, nurses, police)

- 2) Helping pass legislation to further define and clarify the public health portion of where Service dogs can be allowed to accompany their handlers, and make it a Class 3 misdemeanor if violated.
- 3) Hazlewood Act allows 150 hrs free tuition in a public university if the member entered the service in Texas, and in 2009 these benefits were passed onto the member's spouse or children. Some Universities estimate they are losing \$110m and want legislature to fund the shortfall, allow increased tuition on paying students to cover it or have the member means tested.

Will be attending the National Guard Convention in Dallas 20-22 Mar, and in Washington at the Army Retiree Council 17-22 April
