of the Surviving Spouses who would represent at staff meetings. Asked Trish to ensure details about the spouse virtual chapter is included in The Lariat. 5-6 folks have responded to his request for membership committee members. Will send out a similar email for the Surviving Spouse position. Kathie advised she has a friend, Linda R), also known to Kitty, who may be interested but previously had meeting conflicts. Will reach out. One response suggested having a life membership option to help with retention, and another suggested a big get together other than a luncheon (i.e. picnic) where members can freely mingle.

Chapter is made up of 82% of paid memberships, noticed a couple of names on the 3<sup>rd</sup> reminder and will get in touch with those non-renewers.

This month's NRT report from national contains 31 new members and 6 potential who will be sent invitations to join.

Options for life memberships were discussed, receive certificate, expectations of continuing financial support, have events only Lifers are invited to (zoom?), find out if other chapters do it, and how.

Do need to increase Friend of the Chapter category with so many veterans in and around San Antonio.

**VP Programs:** Col David Patrick, USAF (Ret) / Col Brian Afflerbaugh, USAF (Ret) – Brian reported the Happy Hour was a sold out event. Reviewed relatively good rating report though it did not include any comments – will double check the setting for next time.

David reported Goldfein cancelled for March and is replaced by Col Grimm. Kim Jeffries from Haven for Hope has been confirmed and we are still waiting for confirmation on Sean Elliott. Will soon start working on 2025 events. Felix recommended National Parks Service person who attended the Lackland RAD as speaker or just to have a table at a luncheon as a benefit for members. Felix to pass contact info onto David/Brian.

**VP Legislative Affairs:** Maj Jim Cunningham, USA (Ret) – The recent primary was beneficial for Governor Abbott, and the Allred vs Cruz match up should be interesting. Still awaiting interim charged from the state but know at least one will address PTSD relief in the form of marijuana or psychedelics for use by military members.

**VP Marketing and Development:** Col Lisa Skopal, USAF (Ret) – Absent. Lisa sent in the following report: Obtained a new Level 3 Corporate Sponsor, First Command. Also confirmed at the Lackland RAD that Dignity Memorial meant to renew their sponsorship at Level 2, not Level 1, so they will be sending in additional \$\$\$ to meet level 2 renewal. Met Glenn Mederios, Co-owner/General Manager of Xpert Media Mgmt LLC, as a potential Corporate Sponsor and possible local source for Marketing and Golf accessories for MOAA. **VAC/VGSAA Rep:** Maj Jim Cunningham, USA (Ret) – Nothing to report following submission of the Chapter VOYA.

Army Chief of Staff's Retiree Council Washington DC & JBSA Retirees Council: COL Felix Santiago, USA (Ret) – Will be called to Active Duty in April for a week in Washington DC. The Lackland RAD had over 600 attendees.

**Transition Liaison Officer:** Lt Col Kitty Meyers, USAF (Ret) – Absent. No report.

Blue Skies of Texas Satellite Chapter Representative: Col Dan Van Syoc, USAF (Ret) – Collection boxes for socks for Soldiers' Angels is going well. Will begin working on the September luncheon with the BST staff.

ARC Satellite Chapter Representative: (Open) - No report.

**Volunteer Coordinator:** Col Pete Schaub, USAF (Ret) – Absent. Pete submitted the following report: Made contact with Soldier's Angels and would like to suggest that we begin a volunteer partnership with them in order to promote our chapter's involvement in the community and support their charter. Soldier's Angels is a national 501(c)3 charity who supports deployed military members, veterans, and families

through various projects and programs. Although their mantra is "May no soldier go unloved, may no soldier walk alone, may no soldier be forgotten, even after they come home," they provide aid, comfort, and resources to all branches of the military.

There are three lines of effort I would propose we adopt:

- 1. Participate in their collection drives.
  - a. The collection campaigns are designed with one goal in mind—bring people together to collect items our service members and veterans need. Some are necessity focused, others morale focused.
  - b. Upcoming drives:
    - i. Care package items for deployed members (Apr and Jun)
    - ii. Military Working Dog items (May)
    - iii. Warm Winter Drive for Homeless Vets (Jul, Aug, Sep)
    - iv. Holiday Stocking Stuffers for deployed members (Oct, Nov, Dec)
    - v. Treats for Troops (Nov, Dec)
  - c. I suggest we have a collection box located at the check in area at our monthly events. I'd like to advertise the drive in the Lariat, the luncheon advertisement and invitation. The information would include the drive, its purpose, and what supplies would be requested. Items can be purchased and dropped off, or procured via Amazon who can send it directly to Soldier's Angels.
- 2. Participate in one of their projects as a Chapter, perhaps a group of 20 or so.

- a. There are packing activities at their warehouse that require groups of 10-40 every few weeks. Currently there are no openings through end of April. This would give us time to spread the work regarding our chapter's desire to support them in this area.
- b. I propose that we invite Jana Evens, Soldier's Angels Area Manager, to one of our monthly events to set up an information table and provide her with a few minutes to discuss their organization with the audience. Afterwards we will be able to announce an event we want to support and hopefully have people already interested.
- c. We can then sign up for a group event every quarter and make it a reoccurring event.
- 3. Advertise their multiple volunteer opportunities where our membership can assist on an individual basis.
  - a. Events include (info found at https://soldiersangels.org/volunteer/):
    - i. Watering plants and gardening at the VA Polytrauma Center
    - ii. Supporting Outreach and Resource
    - iii. Manning a Coffee and Snack cart at the VA
    - iv. Assisting with Military and Veteran Food Distribution
    - v. Feeding the Homeless
    - vi. Virtual support (things you can do from home like writing letters)

Surviving Spouse Coordinator: (Open) - No report.

VP Personal Affairs: (Open) - No report.

**VP Public Relations/Marketing:** LtCol Kathie Estrada USAF (Ret) – Nothing additional to report. David mentioned an item from the MACEF Board meeting was to have a chapter LinkedIn page set up.

**Administration:** Trish Meserve – March renewals consist of 95, of which 35 are to be mailed. 12 are slated to be deleted.

#### **Old Business:**

- 1. New chapter coins have been approved for retail sale on and off post.
- 2. Happy Hour discussion of increasing volunteerism produced comments such as ZOOMing our staff meetings so members can watch, and in addition to a list of positions open include the job description in The Lariat, plus personally contacting members to see if they would be interested.
