Next year will have individual pictures of each winner and formalize the planning schedule to meet every 2-3 months to make sure things are on track. Survey Monkey results indicated a very successful event! Awards: Involved with 100 High Schools and approximately 10 colleges. Schedule is being updated daily. The Texas Military Officers Association, a non profit transition organization, hold regular meetings with military officers on the 2<sup>nd</sup> Thursday of each month, some of whom are MOAA members. Hoping to persuade some of these to join an Austin Chapter of MOAA. David suggested we should include the Austin Chapter membership in our luncheon blasts.

Barbara Ramsey has spoken to Terri Coles regarding Austin and if a Work Plan is created financial remuneration could be arranged. She is due to attend the next Quarterly TCC meeting in June. Jim is also working on possible satellites in the Valley and Coastal Bend areas by talking to the JROTC instructors at the award presentations.

David Patrick advised a master calendar of the Newcomer Welcome dates be created and assigned to those wanting to man the table.
