President: Maj Jim Cunningham – Busy month as State Legislative VP for Texas Council of Chapters testifying before Congress in Austin. TCC and Texas Coalition of Veterans Organizations have four main priorities. Two of which are 1) 100% disabled property tax transferability to surviving spouses or dependent children, that if passed will require a constitutional amendment that will go on the ballot in November 2) recognition of Service Disabled Veteran Owned Businesses.

The Alliance for Veterans & Families (AVF), in conjunction with San Antonio Coalition for Veterans is sponsoring the first veterans informational program on June 23rd. Need lots of publicity. Also working on Spiritual Outreach of congregations, regardless of denomination, to train them to assist veterans. MOAA National is also hosting a program similar to AFV in Huntsville and Tyler to offer assistance to veterans. The Texas Veterans Commission is also interested in what AFV is doing and how they can help.
