MINUTES OF STAFF MEETING Thursday May 6, 2010

Meeting was called to order by Exec VP Jim Cunningham at 0900 hrs. A quorum was present and acting throughout the meeting.

Secretary: Col David Patrick – Minutes were reviewed and approved for filing.

President: LtCol Ed Marvin - Absent, no report.

Executive VP Operations: Maj Jim Cunningham – Attended Storming of the Hill together with Ed Stone (TCC President). Despite recession and lack of monies received much support from the congressmen who have pledged to do all they can for the military.

Attended the first hearing of the Veterans Affairs Committee in Austin where discussion centered on a single point of contact for the military for the entire state. Falls in line with current VCAT initiatives. May expand current 211 service.

Vice President Administration: (Open) Passed around sign up sheet for upcoming ROTC presentations. Gold bars successfully handed out at both UTSA Army and Air Force award ceremonies.

VP Membership: LTC Randy Hoff – Mavis and the Calling Committee have done an excellent job at recruiting and continue to bring in new members from the MOAA listing. 16 were submitted just today. Extravaganzas have been light on attendance but expecting more traffic during the summer. Semi annual recruiting email has been forwarded to MOAA but they will hold off until after the upcoming campaign. David Patrick is working with AFV on sending out a joint collaboration effort in the form of a recruiting postcard. Has submitted all appropriate paperwork for setting up a recruiting table at BAMC, now waiting on a response. Jim Cunningham added that many recruiting ideas were submitted to MOAA national from other councils at the Presidents meeting in Nashville and MOAA is reviewing them. Revised numbers are 1091 total (284 Active, 239 Aux and 568 Retired).

VP Programs: (Open) – Jim Cunningham reminded all of the May luncheon at the Gateway Club with General Swan. AFV has 6 so far that have signed up. 3rd Quarter TCC meeting will be hosted by San Antonio on Aug 20-21. Jim Cunningham working on hotel in 1-10/1604 area – need particulars to advertise heavily in The Lariat to encourage general membership to attend, especially the Friday night dinner.

Treasurer: Vaughn Caudill – Financial Review Committee concluded all was OK and that no fraud or fiscal abuse was noted. Some recommendations were made on how to proceed for future audits which will be discussed at a later date. Has started working on Form 990 and will get it submitted to IRS by May 15 deadline. Will need to include list of officers. Current financials were reviewed. It was noted social events continued to lose money, Golf tournament proceeds had increased and although chapter was currently ahead of the budget it will likely become a negative situation as the year progresses.
