VP Membership: COL Felix Santiago, USA (Ret) – Membership chart shows 92 Active Duty, 142 Surviving Spouse, 32 Former, 652 Retired for a total membership of 918 indicating a net gain of 2. Paying members are realistically at 87% after discounting Lifers and Active Duty. There are still a large number of members over the age of 90, including 30 over 100. Felix has been researching various sources to try and correct any errors – found at least 3 member names in the grave locators in the national archives.

On this month's NRT listing from MOAA national there are 19 new members and 15 potentials. Trish to send out the appropriate invitations.

MOAA's no contact list has over 4300 names on it, including some the chapter leadership. Will provide an article in The Lariat asking folks to update their MOAA national profile and "opt in" to allow emails from the local chapter.

Attended the recent TCC meeting and noted only 14% of MOAA's membership are members of a local chapter so we are in line with those numbers also.

VP Programs: Col David Patrick, USAF (Ret) – David provided the latest program calendar and survey results from the Ft Sam Golf Course luncheon and noticed the ratings are trending up. The food was very good, and the room always looks nice. The June social event will be a happy hour at the Petroleum Club and still awaiting confirmation of a replacement for General Evans who had to cancel because of a scheduling conflict. Felix suggested a combo of PTSD groups could introduce themselves and give a short speech with Q&A.

VP Legislative Affairs: Maj Jim Cunningham, USA (Ret) – Absent. He submitted the following report: MOAA is asking members to send their senators a note via the Action Center to support the PACT Act this next week when it comes to a vote. This is HR3967. It would provide the following:

- Provide access to care for 3.5 million veterans exposed to burn pits.
- Add 23 respiratory illnesses/cancers to the list of ailments presumed to be connected to toxic exposure.
- Expand Agent Orange presumptive exposure to include those with service in Thailand, Laos, and Cambodia during certain periods.
- Invest in VA research, facilities, staffing, and claims support surrounding toxic exposure.

We need to also send letters via the Action Center in support of the Major Richard Star Act and the Tricare Co-Pay relief acts.

Where the state is concerned, the Governor has asked that committees be formed to study what needs to be done after the Uvalde massacre. This is the same thing that he did with Sulfur Springs, and it resulted in no legislative action. This appears to be the same tactic and will thus result in nothing being done. Many legislators both Republican and Democratic are demanding that he call a special session, however he is resisting.

VP Marketing and Development: Col Lisa Skopal, USAF (Ret) – (See Scorecard update).

President: Lt Col Kitty Meyers, USAF (Ret) – Attended the AETC Change of Command at Randolph AFB for General Brian Robinson. Also attended TCC meeting and a SA Chamber event at UTSA Women 2 Women. Kitty advised she was not chosen as a MOAA Board member

A good response was received to Pete Schaub's email to chapter volunteers advising them of an opportunity at a Soldiers' Angels food distribution event and the putting together of care packages for deployed servicemembers.

Also, Soldiers' Angels were the winners of the \$100,000 Ancira Non-Profit giveaway.

Priority 2 (Lisa)

Lisa has gained another Corporate Partner and a Golt Tournament Hole sponsor.

Also working on marketing for the Big Give scheduled for Sept 22 by interviewing a Lt Col who had received a chapter scholarship as an ROTC cadet. She will begin concentrating on soliciting for the Golf Tournament.
