# MINUTES OF STAFF MEETING Thursday, June 6, 2013

Meeting was called to order by President Jim Cunningham at 0900 hrs. A quorum was present and acting throughout the meeting.

Invocation given by Chaplain Taylor and pledge led by Jim Cunningham.

Secretary: Col David Patrick - Minutes from May were reviewed and approved for filing.

**President:** Maj Jim Cunningham – Chapter was placed 2<sup>nd</sup> runner up for the Communications Award in the website category. Attended VIP event (Veterans Information Program) in conjunction with Greater San Antonio Chamber of Commerce where veterans can obtain information regarding their healthcare, benefits etc. Part of Got Your Six production by the Chamber which is similar to the Community Blue Print.

Attended reception hosted by General Caldwell, provided useful networking with Active Duty Generals. SA Area Foundation is creating a Military Leadership Council to be made up of the "movers & shakers" in Bexar County and the 12 surrounding counties. Its goal is to coordinate activities for the benefit of the military from both military and civilians led by General Valenzuela.

Legislative Update – Some of the desired bills passed included 1) allowing Service Disabled Veteran Owned Businesses to compete for State contracts in the same category as HUBs (historically underutilized businesses: based on race, gender and ethnicity). 2) 100% property tax exemption for the surviving spouse of service members killed in action or whilst on active duty.

Did not get the revision on the cut off date (Jan 1 2009) for the property tax waiver for spouses of military personnel came into effect. Took too slow moving through the calendar phase. Also did not get the readjustment of \$12,000 cap on property tax waiver for partially disabled – would have cost the state over \$25 million.

As far as Federal legislative news it is being insisted upon not to increase Tricare fees. MOAA national will be watching this carefully.

Currently talking with the Army Retiree Council on ways to involve more retirees in post and community activities. Main hurdle is lack of communication and recruitment. AUSA and AFA experience the same problem with only a small core of volunteers doing all the work.

Attended MOAA conference in Kansas City last month. Was approached regarding the possibility of enveloping the Kerrville chapter as a satellite chapter.

Treasurer: Col Vaughn Caudill – Absent. Financials were reviewed for May and approved for filing.
