Secretary: Col David Patrick – Minutes from June were reviewed and approved for filing. Reminded Executive Staff of upcoming Board meeting on 18th.

President: Maj Jim Cunningham – Received a letter from MOAA national regarding the Educational Assistance Fund. Approximately 60 area students received scholarships from MOAA. Suggests sending congratulatory letter from local chapter to each one. Jointly with David Patrick and Ed Marvin, has been busily engaged in the Annual Meeting preparations. Had conference call with MOAA national. Also working on Alliance for Veterans and Families (AVF) projects. David Patrick as Co-chair put on a very successful Veterans Benefit Fair.

Presentation: Craig Erickson spoke on his work with the Bexar County Veterans Service Office and offered his thanks and appreciation for all MOAA-AC does to help the veterans' activities in the city and county. Outlined services offered for the burial of veterans who are homeless or who have no next of kin. Funeral services are provided free of charge by Dignity Funeral Homes (Roy Akers) typically on Wednesday mornings. Honor guards are provided by Cole High School. All are welcome to attend – will send email to those interested if you provide email address.

Veterans Treatment Court was created last year to assist vets who get into trouble. Currently there are 30 veterans participating. They are being treated for PTSD or substance abuse and the aim is for them to get help and get their record expunged. Goal is to have 80 in the program by the end of next fiscal year. Next Commissioner's Court will be Aug 29th.

Mentor program due to start soon and if interest in assisting contact Craig. Planning to meet with a couple of interested groups who can take over the mechanics of it and run the program.

A reunion is being planned on Sept 3 for the members of the Bell of San Jacinto, a light aircraft carrier from WWII. Looking for navy speaker, Kerry Green suggested he contact USAA Speaker Bureau.

Presented Community Service Award, the Bexar County Leroy V. Greene, Jr award to past president, Edward L. Marvin. The award recognizes a Bexar County resident who has made positive contributions to the well being and quality of life of veterans and military service members and their families. Deadline for this year's nominee is September 15.
