Secretary: Col David Patrick, USAF (Ret) – Absent. Minutes from the August meeting were reviewed and approved for filing. Motion made by Jim Cunningham, seconded by Vaughn Caudill. Vote was unanimous.

Treasurer: No financials to review.

VP Membership: Maj Jim Cunningham, USA (Ret) Membership statistics not available for review. The July membership stands at 1063 consisting of 208 Active Duty, 158 Surviving Spouses, 21 Former Military and 676 Retired. Membership numbers continue to be an issue. MAJ Cunningham advised that membership has increased by a few. Has contacted the Morgans at the Army Residence Community and offered assistance in the creation of the satellite. They are planning to meet with Grace Newton at the ARC to discuss an initial planning meeting. He will assist as they request. Has a list of potential folks in the Austin area regarding a satellite. Is scouting locations for a preliminary meeting. Folks include members of the former chapter as well as new contacts. The newly created Army Futures Command with 500 located in the Austin area will be a population to connect. His connections with Army North CC. Major General Richardson will be an asset as she is the spouse of the Futures Command Deputy Commander. Also discussed request of Texas Council of Chapters to hold the December 6/7 meeting at Blue Skies of Texas. Discussed dinner location and other logistic details.
