Is concerned with Operations account cash flow for early next year – will get larger chunk of dues in February, advertising in March & May and Golf Tournament not until October.

VP Membership: COL Felix Santiago, USA (Ret) – Membership has been able to stay above the 1400 mark. Did lose 23 in the last month and personal emails have been sent to them encouraging them to reconsider. Despite the losses the membership total remains 23% above the Jan 1 numbers.

Working with the Military Family Readiness Center their virtual meetings have provided over 1100 service members a MOAA-AC flyer giving exposure and potential memberships to the officers. Member deletions are done for many reasons – not necessarily a desire not to belong.

As an organization we must continue to identify, seek meaningful engagement and recognize the diverse membership segments, e.g. over 90 population, young generations, etc. Meaningful interaction with our members will enhance our recruitment and retention rates.

Current membership stands at 1434 consisting of 388 Active Duty, 177 Surviving Spouses, 52 Former Military and 818 Retired.

VP Programs: Col David Patrick, USAF (Ret) – Absent. David has lined up the first 6 months of next year – locations are booked but depending on the COVID-19 status they may also remain virtual.

VP Legislative Affairs: Maj Jim Cunningham, USA (Ret) – Following the elections there will be some new representatives. The speaker of the house will need to be chosen to replace the incumbent retiring one, and after that the new chair of the Veterans Committee will be chosen. The legislative session will concentrate on how best to spend the reduced amount of money available without dipping into the Rainy-Day fund.

Will review committee members in the chapter to see where changes will need to be made.

President: LtCol Kitty Meyers, USAF (Ret) – The Red, White & You Hiring Fair was a highly successful virtual event. 1295 job seekers logged on and 131 employers. Kitty, David and Stephan oversaw the Veterans Resources Office. Received very positive responses from participants. Kitty was nominated by Workforce Solutions Alamo for the Community/non-profit project of the year category and was selected as a recipient of the 2020 Alamo Area Council of Governments (ACOG) Regional Awards. Kitty thanked everyone for their contributions to the chapter and how their connections impact the community.

Scorecard:

Priority One: Discussion revolved around the addition of "Especially Paid Memberships" addition – general consensus was the it was already implied paid memberships are better than free and that although it was an internal document (but accessible on the chapter website) it would take away from the less tangible benefits of being a member. Recommendation is for the additional wording to be removed.

Similarly, the discussion of the change to the Goal increasing paid memberships from 65-70% to 75% resulted in changing "increase" to emphasize and removing the % number.

Priority Two: Removing 2.4 which was already covered in Priority One was unanimously agreed to. Lengthy discussed on 2.9 (Increasing Dues from \$20 to \$25) resulted in a close vote to remove this action for the time being. A dues increase is an option and will be considered again during the year. Following this staff decision, it will be provided as input to the Board at a regular formal Board meeting.
