#### Increase Revenue

- Add advertisers as luncheon sponsors to offset or partially offset the cost of meals. (To be discussed with Lisa)

#### Reduce mailing costs

- -- Send thank you letters electronically until a certain threshold (\$3,000?). 300+ thank you letters sent annually.(TBD)
- -- Reduce hardcopy membership renewal reminder letters from 3 to 1. Focus on electronic means or phone calls. (TBD)

#### Reduce office expenses:

- -- Explore the option to print on the copier versus desktop printer (\$70/cartridge). Discuss with copier rep and verify this option is included in the existing contract.
  - -- Verify Microsoft 365 is purchased for non-profit organizations (slightly cheaper). (Verified).

#### Review annual insurance policies:

- -- Need a legal opinion, but is liability insurance necessary for the on-base location? (Currently yes)
- -- I will request a quote on the D&O insurance as our PTA organization has a similar insurance policy for \$256 annually. (TBD)

#### 2022 Budget:

We have high expectations for revenue and sponsorships, and that outflow will be reduced. The expected deficit is reasonable, especially following this year's successes. David Patrick made a motion to accept the 2022 Budget as presented. Seconded by Jim Cunningham. Vote was unanimous.

**VP Membership:** COL Felix Santiago, USA (Ret) – Current chart shows 208 Active Duty, 150 Surviving Spouse, 62 Former and 827 Retired giving a total of 1247, with a net loss of 25 (2%). This is mainly due to transitioning/PCS-ing Active Duty, and the usual pattern throughout the year.

In person Newcomer's events are scheduled to resume in January which should increase recruitment. The Final Final listing of 336 members is made up mostly of the initial influx of NRT prospects when we entered Jan through June 2020 reports all at once, but retention has been about 20% which was expected. Normal retention notices will be issues and Felix will personally reach out to most but losing this many names will make the chapter leaner and the % of paid memberships will increase.

To increase retention more emphasis must be placed on the communicating the legislative advocacy that is done at the city and state level.

**VP Programs:** Col David Patrick, USAF (Ret) – The survey results from the luncheons were reviewed. Positive remarks indicated feeling comfortable is important will ensure members return.

Reviewed the draft programming for 2022, some excellent speakers are lined up. We will be back at the Ft Sam Golf Club beginning January and they are only offering buffets because of staff shortages. **VP Legislative Affairs:** Maj Jim Cunningham, USA (Ret) – Little is happening at the state level currently, though the passage of the two constitutional amendments in the November ballot will assist surviving spouses with their property taxes.

"The constitutional amendment to allow the surviving spouse of a person who is disabled to receive a limitation on the school district ad valorem taxes on the spouse's residence homestead if the spouse is 55 years of age or older at the time of the person's death."

"The constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of all or part of the market value of the residence homestead of the surviving spouse of a member of the armed services of the United States who is killed or fatally injured in the line of duty."

At the federal level items being worked on include benefits for presumptive illness for veterans. Both Jim's and Kitty's positions on the Texas Veterans Commission committees are involved in looking at solutions to suicide prevention and homelessness of veterans. The Texas Land Board, providing home loans to veterans is also on the TVC's radar.

**President:** LtCol Kitty Meyers, USAF (Ret) – As well as the TVC Committee, Kitty is participating in the Texas Veterans Network committee managed by ACOG, and the San Antonio Chamber's Military Affairs Committee.
