To keep \$15,000 in reserves the amount we can award in 2021 for scholarships is currently at \$18,000.

**VP Membership:** COL Felix Santiago, USA (Ret) – Lost 11 Active Duty, 3 Surviving Spouses and 1 Former member and gained 7 retired members since last month's report. The 14 who are due for deletion have been contacted individually. Felix to share with Kitty, David & Jim the Master list of those 25 members who are shown to be over the age of 100 folks for possible special attention. In tracking paid memberships there are now 589 currently versus 603 at the beginning of the year, the difference of 14 does not amount much in the way of membership dues.

Discussed the free memberships being given to the Near Real Time Report Members we receive from MOAA national that consist of MOAA members moving into our area. Those with an email are automatically added and then our roster is updated at national and we get a stipend on these as

part of the MOAA recruitment campaign. The ones without email are sent a letter and an application form encouraging them to join for a free year. If they do, they also become part of the resulting stipend. Jim Cunningham made a motion to reduce the free year to 3 months, seconded by David Patrick. Motion carried.

There are also 282 Austin area members who have been receiving all emails from us for well over a year, maybe 2, including The Lariat. David to pen an email we can send advising they should become dues paying members. They are currently not included in the membership count as all we have are emails, no names.

Current membership stands at 1427 consisting of 377 Active Duty, 174 Surviving Spouses, 51 Former Military and 825 Retired.

**VP Programs:** Col David Patrick, USAF (Ret) – The in-person events have been cancelled through March because of the pandemic. December's speaker is Lane Bourgeois, the RAFB Historian. Will be using this as an opportunity to showcase the 90<sup>th</sup> Anniversary Fiesta Medal which will be given to folks donating at least \$100 to the ACEF. 3 email blasts will be sent out between now and the webinar. The webinar last month had a low attendance, but it was a good presentation.

**VP Legislative Affairs:** Maj Jim Cunningham, USA (Ret) – At the Federal level refinements are being worked to the SBP/DIC which will fade over the next 2-3 years, as well as any changes to the MTF. The reduction on the 18 thousand medical billets has been frozen.

At the state level more monies have been found but there will still be a \$4.5 billion deficit and all budgets will be cut by at least 5%. Questions unanswered include who will be the speaker of the house and how congressional hearings will be held considering the pandemic? The number of bills that can be filed may be limited. Benefits already in place likely will not be reduced but introductions of new ones will be stymied.

**President:** LtCol Kitty Meyers, USAF (Ret) – As President a letter was sent to the Pentagon supporting the assignment of the Space Force to San Antonio.

Continuing to work with the San Antonio Chamber's Military Affairs Committee and will participate in the TCC meeting this Saturday via Zoom.

David Patrick pointed out Kitty was recently recognized by MOAA National as one of the first ever Change Makers for her work in Transition – see write up on Page 54 of the Military Officers Magazine.

#### Scorecard:

Priority One: Action steps were reviewed with no additional comments from Felix.

Priority Two: Lisa will be holding her first Advertising Committee meeting on Wednesday via Zoom. Discussion was held whether to increase the cost of the Corporate Partnership, but it was decided to leave as is until the pandemic has been resolved.

Kitty advised the golf tournament may have hit a snag as River Crossing may not be amenable to an outside tournament. The Golf Committee will meet today and the % of the proceeds will be on the agenda.

Vaughn Caudill and Felix Santiago to connect offline to discuss the number of paid memberships and the budgeted dues for 2021. They will present their findings and recommendations at the January staff meeting.
